General James T. Conway

34th Commandant of the Marine Corps Naples Beach Hotel, Everglades Dining Room Friday, February 8, 2013



General Conway was born in Walnut Ridge, Arkansas and is a graduate of Southeast Missouri State University. He was commissioned in 1970 as an infantry officer. His company grade assignments included multiple platoon and company commander billets with both the 1st and 2nd Marine Divisions; Executive Officer of the Marine Detachment aboard the USS Kitty Hawk (CVA-63); series and company commander at the Marine Corps Recruit Depot in San Diego; aide to the

Commanding General, and Director, Sea School.

As a field grade officer, he commanded two companies of officer students and taught tactics at The Basic School; he also served as operations officer for the 31st Marine Amphibious Unit to include contingency operations off Beirut, Lebanon; and as Senior Aide to the Chairman, Joint Chiefs of Staff. Promoted to Lieutenant Colonel, he was reassigned to the 2d Marine Division as Division G-3 Operations Officer before assuming command of 3d Battalion, 2d Marines in January 1990. He commanded Battalion Landing Team 3/2 during Operations Desert Shield and Desert Storm. Selected for colonel, he served as the Ground Colonels' Monitor, and as Commanding Officer of The Basic School. His general officer duties included Deputy Director of Operations, J-34, Combating Terrorism, Joint Staff, Washington, D.C.; and President, Marine Corps University at Quantico, VA. After promotion to Major General, he assumed command of the 1st Marine Division. In November 2002, Major General Conway was promoted to Lieutenant General and assumed command of the I Marine Expeditionary Force. He commanded I Marine Expeditionary Force during two combat tours in Iraq. In 2004, he was reassigned as the Director of Operations, J-3, Joint Staff, in Washington, D.C.

General Conway's personal decorations include the Defense

Colonel David W. Sutherland is a veteran of 29 years Active Federal Service in the United States Army, and a veteran of two wars; he is a vocal advocate for our returning service members, veterans, their families, and the families of our fallen; and a mentor for thousands of organizations enabling those who have served.

He was commissioned an Infantry Officer in 1983 and holds a Bachelor's degree from Bowling Green State University in History and Economics and a Masters in Strategic Studies. Colonel Sutherland attended all levels of military education including Airborne, Ranger, Jumpmaster, the U. S. Army Command and General Staff College, and is a Senior Service College Graduate -Advanced Operational Studies Fellowship.

He served in staff positions at Battalion through Division. While assigned as a Brigade staff officer he deployed to Kuwait as part of Operation Vigilant Warrior in 1994. Colonel Sutherland has also

commanded at all levels from Platoon through Brigade. As a Company Commander he deployed to South West Asia as part of Operation Desert Shield and Desert Storm. While commanding 3rd Heavy Brigade Combat Team "Greywolf," 1st Cavalry Division Sutherland deployed to Iraq as part of Operation Iraqi Freedom. Colonel Sutherland served as the Coalition Force Commander in Diyala Province from October 2006 - December 2007, which included surge operations. In July 2008, Colonel Sutherland was assigned to the Joint Staff as the Division Chief in J5 (Plans, Policy, and Strategy), Middle East Region. Colonel Sutherland's final assignment prior to retirement was as the Special Assistant to the Chairman of the Joint Chiefs of Staff with principle focus on Warrior and Family Support.

He is currently the Executive Director of the Center for Military and Veteran Community Services (Dixon Center). Along with their sponsor, Easter Seals, the Center has cultivated a network of over 20,000 organizations, volunteers, and like-minded individuals in more than 550 communities. Dixon Center's mission is to enable veterans and military families where they live. Sutherland is also the president of The Sutherland Partnership, Inc.

Awards and decorations include, among others, the Defense Superior Service Medal, the Legion of Merit with oak leaf cluster, the Bronze Star Medal with oak leaf cluster, the Purple Heart, the Meritorious Service Medal with six oak leaf clusters, the Joint Service Commendation Medal with two oak leaf clusters, the Ranger Tab, Combat Infantryman's Badge Second Award, and Senior Parachutist Badge. He is also the 2008 Freedom Award recipient presented by the No Greater Sacrifice Foundation and the 2011 Meritorious Service Award recipient presented by the National Coalition for Homeless Veterans for his work on behalf of returning Service Members, Veterans, Military Families, and Families of the Fallen.

Colonel Sutherland, and his wife Bonnie, have two sons, Andrew and Patrick.
