## **Ambassador John Bolton**

Fmr. Ambassador to the U.N. Friday, January 8, 2021

John R. Bolton served as Assistant to the President for National Security Affairs from April 8, 2018 until his resignation on September 10, 2019. From January 2007 until April 2018, he served as a Senior Fellow at American Enterprise Institute in Washington.

Ambassador Bolton was appointed as United States Permanent Representative to the United Nations on August 1, 2005 and served until his resignation in December 2006. Prior to his appointment, he served as Under Secretary of State for Arms Control and International Security from May 2001 to May 2005.

Throughout his distinguished career, Ambassador Bolton has been a staunch defender of American interests. While Under Secretary of State, he repeatedly advocated tough measures against the nuclear weapons programs of both Iran and North Korea, and the proliferation of weapons of mass destruction worldwide. He led negotiations for America to withdraw from the 1972 Anti-Ballistic Missile Treaty so that the Bush Administration could proceed with a national missile-defense program.

Ambassador Bolton has spent many years of his career in public service. Previous positions he has held include assistant secretary for International Organization Affairs at the Department of State, 1989-1993; assistant attorney general, Department of Justice, 1985-1989; assistant administrator for Program and Policy Coordination, U.S. Agency for International Development, 1982-1983 and general counsel, U.S. Agency for International Development, 1981-1982.

Ambassador Bolton is the author of Surrender is Not an Option: Defending America at the U.N. and Abroad, How Barack Obama is Endangering our National Sovereignty, and *The Room Where It Happened: A White House Memoir*.

Ambassador Bolton was born in Baltimore, Maryland. He graduated with a Bachelor of Arts degree, summa cum laude, Phi Beta Kappa, from Yale College in 1970, and received his Juris Doctor from Yale Law School in 1974. He currently resides in Maryland with his wife, Gretchen. They have one daughter, Jennifer Sarah, who also graduated from Yale College, and received her MBA and SM degrees from MIT in 2014 and is currently a senior manager at Nissan's manufacturing facility in Nashville.

#### Chad A. Mirkin, Ph.D.

Director of the International Institute for Nanotechnology Northwestern University Friday, January 22, 2021

Dr. Chad A. Mirkin is the Director of the International Institute for Nanotechnology and the George B. Rathmann Professor of Chemistry, Chemical and Biological Engineering, Biomedical Engineering, Materials Science & Engineering, and

Medicine at Northwestern University. He is a chemist and a worldrenowned nanoscience expert, who is known for his discovery and development of spherical nucleic acids (SNAs) and SNA-based biodetection and therapeutic schemes, Dip-Pen Nanolithography (DPN) and related cantilever-free nanopatterning methodologies, On-Wire Lithography (OWL) and Co-Axial Lithography (COAL), and contributions to supramolecular chemistry and nanoparticle synthesis.

Dr. Mirkin received his B.S. degree from Dickinson College (1986) and a Ph.D. degree from the Penn State University (1989). He was a National Science Foundation Postdoctoral Fellow at the MIT prior to becoming a professor at Northwestern University in 1991. He has authored over 770 manuscripts and over 1,200 patent applications worldwide (over 350 issued) and founded multiple companies, including AuraSense, Exicure, TERA-print, and Azul 3D.

Dr. Mirkin has been recognized with over 230 international awards, including the Kabiller Prize in Nanoscience and Nanomedicine, the SCI Perkin Medal, the Wilhelm Exner Medal, the RUSNANOPRIZE, the Dan David Prize, and the Sackler Prize in Convergence Research. He served for eight years on the President's Council of Advisors on Science & Technology, and he is one of very few scientists to be elected to all three U.S. National Academies. Dr. Mirkin has served on the editorial advisory boards of over 20 scholarly journals, and he is the founding editor of the journal *Small*. At present, he is an Associate Editor of *JACS* and a *PNAS* Editorial Board Member.
