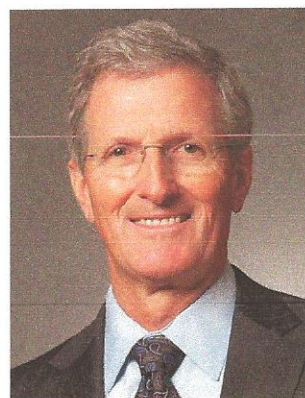

Page received a bachelor's degree in economics from the University of North Dakota. He was born in Bottineau, N.D.
