Alex Brill is a senior fellow at the American Enterprise Institute (AEI), where he studies the impact of tax policy on the U.S. economy as well as the fiscal, economic, and political consequences of tax, budget, health

care, retirement security, and trade policies. Brill is also the founder and CEO of Matrix Global Advisors, an economic consulting firm based in Washington, DC.

Brill is the editor of “Carbon Tax Policy: A Conservative Dialogue on Pro-Growth Opportunities” (2017) and the co-author, with Alan D. Viard, of “The Real Tax Burden: More Than Dollars and Cents” (2011). He has testified numerous times before Congress on tax policy, energy policy, labor markets and unemployment insurance, Social Security reform, fiscal stimulus, the manufacturing sector, and drug competition.

Previously, Brill served as the policy director and chief economist of the House Committee on Ways and Means (2002-2007) and on the staff of the White House Council of Economic Advisers (2001-2002). He has also served on the staff of the Simpson-Bowles Commission and the Republican Platform Committee (2008).

Brill has an M.A. in mathematical finance from Boston University, and a B.A. in economics from Tufts University. He and his wife live in Arlington, VA, with their two children.
