John D. Negroponte

Former Deputy Secretary of State Director of National Intelligence U.S. Representative to the United Nations Naples Beach Hotel Friday, January 7, 2011



John D. Negroponte, a United States career diplomat and national security official, held government positions abroad and in Washington and has been ambassador to Honduras, Mexico, the Philippines, the United Nations and Iraq. In Washington, Ambassador Negroponte served twice on the National Security Council staff first as director for Vietnem in

Council staff, first as director for Vietnam in the Nixon Administration and then as deputy

national security advisor under President Reagan. He has also held a cabinet level position as the first director of national intelligence under President George W. Bush. His most recent position in government was as deputy secretary of state, where he served as the State Department's chief operating officer.

While in the private sector from 1997 to 2001, Ambassador Negroponte was executive vice president of the McGraw-Hill Companies, with responsibility for overseeing the company's international activities. During those years the Ambassador was also chairman of the French-American Foundation. Since January 21, 2009, he has assumed the position of vice chairman of McLarty Associates, a leading international strategic advisory firm in

Washington, D.C. Ambassador Negroponte also holds a part-time position at his alma mater, Yale University, as a senior research fellow in Grand Strategy and as a lecturer in international relations.

Ambassador Negroponte has received numerous awards in recognition of his more than four decades of public service, including the State Department's Distinguished Service Medal on two separate occasions, the highest award which can be conferred by the secretary of state, and on January 16, 2009, President Bush awarded the Ambassador the National Security Medal for his outstanding contributions to U.S. national security. Since 2009, he has been serving as chairman of the Council of the Americas/Americas Society, a New York-based NGO which advocates for commercial and cultural relations in the Western Hemisphere. Ambassador Negroponte is married to Diana Villiers Negroponte and they have five children.

Governor of Mississippi Naples Beach Hotel Friday, January 28, 2011



Governor Haley Barbour's first election in 2003 marked the largest voter turnout in Mississippi gubernatorial history, and he was reelected in 2007 with 58.2 percent of the vote. The Yazoo City, Mississippi, native is only the second governor since Reconstruction to be elected to a second consecutive term as Mississippi's chief executive.

In the face of the worst natural disaster

in American history - Hurricane Katrina, which struck on August 29, 2005 - Governor Barbour created the Governor's Commission on Recovery, Rebuilding, and Renewal to develop a broad vision for opportunities to help South Mississippi rebuild bigger and better than ever.
